# WATER TOWER PARK RULES AND REGULATIONS

Note: The following rules and regulations are summaries and clarifications of the City Code of Ordinances, 5:1.1 Use of Parks. Upon request, original City Code of Ordinance will be issued.

## **PARK HOURS**

1. The park is open all year around and seven days a week from 6 a.m. - 10 p.m. It shall be unlawful for any person to enter upon or remain in this park after closing hours and before opening hours.

# **MOTORIZED TRAFFIC & PARKING**

- 1. Motor vehicles, motorcycles or bicycles may not be driven on any park area not designated as a driveway or parking area.
- 2. Motor vehicles, motorcycles or bicycles are not to park on any part of the traveled portion of the roadway (driveway) or any area that has not been declared and designated as a parking area.

#### **USE OF PARK**

The facilities are used at your own risk. The City of Menominee will not be responsible for accidents, injuries or loss of property that occur to your and or your guests.

- 1. Anyone using the pavilion and grounds must clean up all debris, leaving the area in good order and the facilities that were used in a neat and sanitary condition.
- 2. Anyone using the pavilion and grounds who wishes to utilize bounce or inflatable houses/amusements MUST provide the Recreation Department with a certificate of liability insurance with limits approved by the City.
- 3. Fires are not permitted.
- 4. Animals (pets) are not permitted.
- 5. No person shall obstruct any walk or drive or injure, mar or damage in any manner any monument, ornament, fence, bridge, seat, tree, fountain, shrub, flower, playground equipment, fireplace, picnic table or other public property within or pertaining to Water Tower Park.
- 6. No person shall use a sound amplification device in excess of the sound level at which the content of such sound is distinguished by persons of average hearing at a distance of thirty feet (30') from the source of such amplification device.
- 7. The park may be declared closed to the public at any time for any interval of time, either temporarily or at designated intervals, when the park is determined that public safety or park maintenance requires.
- 8. Alcoholic beverages are prohibited.
- 9. No person shall paste, glue, tack or otherwise post any sign, placard, advertisement, or inscription whatsoever, nor shall any person erect or cause to be erected any sign whatsoever on any public lands or highways or roads adjacent to a public park.

## PAVILION RESERVATIONS AND PARK ACTIVITIES

1. Appropriate signed documents and reservation fee must be approved, received and on file with the Recreation Department for any pavilion reservations. Pavilion reservations must comply with the following items:

- a. The proposed activity or use of the pavilion will not unreasonably interfere with or detract from the general public's enjoyment of the park;
- b. The proposed activity or use of the pavilion will not unreasonably interfere with or detract from the promotion of public health, welfare, safety and recreation:
- c. The facilities desired have not been reserved for other uses at the day and hour required in the application;
- d. The conduct of such activity will not substantially interrupt the safety and orderly movement of traffic;
- e. The conduct of such activity will not require the diversion of so great a number of police officers to properly police such activity and the areas contiguous thereto, as to prevent normal police protection to the City;
- f. The conduct of such activity is not reasonable likely to cause injury to persons or property, incite violence, crime or disorderly conduct;
- g. Such activity is not to be held for the sole purpose of advertising any product, goods or event, and is not designated to be held purely for private profit, except by recognized nonprofit organizations;
- h. The activity planned shall not create unreasonable noise within the remainder of the park or the surrounding neighborhood by natural or amplified means.
