

RIVER PARK CAMPGROUND GUIDELINES

We've established the following guidelines to help ensure your safety and enjoyment while in our campground and the same for our other registered campers. Those who choose not to observe these guidelines and policies may result in expulsion from our campground or other enforcement action, and without any form of refund. All campground amenities are for the convenience of registered campers only and all persons do so at their own risk.

CHECK IN/OUT TIME (C.S.T.) – PAYMENTS AND FEES

- Check-in begins at 1PM. Please check in at the office upon arrival, prior to setting up. Early check-in fee is \$10.00, based on availability.
- We do not accept credit or debit cards. We accept personal checks, traveler's checks, and cash only. There will be a \$35 service charge for any returned check.
- You must re-register to extend your stay or express your wish for a late check out time by 9 a.m. (provided the site or additional sites are available) Late departure charges will be assessed.
- Check out time is NOON. Please be considerate of arriving campers. Vacate your site by 12 p.m. (Noon)
- Day Visitors and Night Guests (adult 18 or older) Register at office – fees apply (\$5.00 per person/per day).
- Shower facility \$5.00 per person/per day, if not a registered camper.

RESERVATION/ALTERATION/CANCELLATION POLICY

- The first night's deposit is required for each reservation made.
- Cancellation Policy: There is a \$20 cancellation fee for all reservations.
- Reservations cancelled more than 7 days prior to arrival receive a partial refund and will be charged a \$20 cancellation fee.
- Reservations *cancelled within 7 days of the arrival date will be charged a \$20 cancellation fee and will forfeit any deposit.*
- If you need to adjust the length of your stay, please notify us prior to checking in.
- The site will only be held for as long as your deposit allows. After that, your reservation is cancelled.
- There are no refunds or credits for early departure once you have checked in.

CAMPSITE OCCUPANCY/PARKING

- Campsites are rented (18 years or older) 1 camping unit, 1 registered vehicle, Family 1-2 adults and their minor children (17 or younger.) Overnight guests (including family members) will be charged \$5 per person, per night.
- A campsite shall not be occupied by more than 6 persons. Large gatherings are not allowed at individual campsites; however, the pavilion is available on a first come first serve basis or can be rented. Check with the office personnel for pavilion availability.
- All camping units must be backed in (unless on a pull-through site), the tongue of the camping trailer hitch must face the road. Parking on pull-thru sites, pull-in so that the full-service hook-up is on the driver's side.
- Do not park on non-occupied sites. It is courteous to leave sites that you haven't reserved open. Please, if possible, do not park on the grass, especially next to the camping unit. Please check with office personnel if you are unsure of where to park.
- Subleasing/loaning of campsites is not allowed.
- Tents are considered a single camping unit and are allowed only on numbered campsites. One camping unit/tent per site unless approved by office personnel. Additional rates may apply.
- *Parent(s)/Guardian(s)/Grandparent(s), you are responsible for your children/grandchildren.* Minors (17 or younger) must have adult supervision. Please inform minors of campground rules, and campsite lot boundary line.
- Boats and Trailers: Boat trailers must be parked on boat pads. Small boat trailers are not allowed on campsites, unless they fit on the black top site pad. You may rent out an additional site to store boat/trailer.

VISITORS – Visiting hours end at 10 p.m.

- A visitor is considered anyone (including a family member) that is not registered and paid for under your reservation.
- ***Visitors (guest to your campsite), must park vehicle(s) in the outer parking lot, stop at office to check-in. A customary \$5 entry fee (per person/per day) will be charged to these visitors.***
- Any temporary requirement for an additional parking space, as for visitor/guest, (including family member), should be handled by the campsite occupant moving his/her vehicle to the outer parking lot or designated parking area assigned by campground staff (prior notification)
- All persons not registered and paid for (including a family member) are not allowed to use tenant's site without the tenant being present.
- Registered campers your responsible to inform your visitors/guests of campground's policies, rules, and regulations. Visitors/Guests/Campers are to obey all guidelines. Failure to comply will result in termination of your reservation and will be asked to leave the campground. No refunds will be given. Inconsiderate campers or guests will not be tolerated.
- Visiting guests or non-registered campers are NOT allowed to bring pets inside the campground.

PETS

- We believe your pet(s) are part of your family and welcome them. Pets must be kept on a leash, no longer than 6 ft., and must not disturb other campers (for example, excessive barking).
- Pets are not to be left at a campsite or left outside unattended, without their owner. Service animals are allowed in any buildings.
- Each pet owner must clean up after his or her pet immediately. This includes all open grass areas inside and directly outside of the campground. Aggressive pets will not be allowed. There is no designated "dog-walk" inside the campground.

OFFICE/BUILDINGS/PAVILION

- *Attire:* Shoes and shirt must be worn when visiting the office. No alcohol is allowed in the office or any building.
- *Smoking:* No smoking in any building or office. Do not dispose of cigarette butts on the ground. Use fire pits and/or ash urn.
- *Telephone:* A telephone is available in the bathhouse for emergency purposes only. For after-hours, non-emergencies, please call Menominee Central Dispatch at 906-863-6614 or in case of emergency dial 911.
- *Mail Services:* There is no mail service on the property. Please make alternate arrangements.
- *Pavilion:* The pavilion is available for use by our registered campers. The pavilion may be rented for a reserved date by contacting the office. There is a fee for reserving the pavilion.
- *Service Building Cleaning:* Cleaning hours will vary day to day. The bathroom and/or showers may be closed during these times. Signage will be posted.

CAMPGROUND/FIREWOOD/FIREPITS AND COURTESY

- *Speed limit:* Slow, very slow, we have plenty of children but none to spare! Traffic shall not exceed 5 mph.
- *Quiet Hours:* Quiet hours are between 10:30 p.m. and 7 a.m. Show consideration for your neighbor by extinguishing outside lights and eliminating all unnecessary noise by 10:30 p.m.
- *Privacy:* All registered campers, children and visitors please respect other campers' privacy and lot boundaries. Use roadways and sidewalks.
- *Fires:* Fires are to be contained in the fire pits only! Do not leave the fire unattended at any time. Extinguish the fire completely when leaving the campfire area. Please do not let campfires "smolder". Do not burn garbage or any other materials besides firewood.
- Do not bring or move firewood to the campground from other states or counties. Unburned wood should not be removed from firepit(s) (except for the campground personnel)
- *WIFI Guidelines:* We offer free basic WIFI throughout the campground. Speed and availability are highly dependent on use. Please be considerate of your neighbors by logging off the network when you are not using it. Campground WIFI is not intended for gaming or video streaming.
- *Carpeting/Clotheslines:* Carpets or mats are not to be placed on grass over a long period of time (maximum 3 days). Please roll up carpets or mats at night. Additional charges will be assessed for damaged areas. Temporary clotheslines are allowed under awnings. Clotheslines between trees are not allowed.
- *Site Maintenance:* you are responsible for maintaining your campsite in a neat, clean, and orderly fashion, limit to 1 or 2 small lawn ornaments, too many will result in removal. NO site modifications allowed unless approval was granted. If any of your property is in disrepair or is in violation of any Health Department standards, you will be notified, or your property may be tagged. This requires your immediate attention, or you risk the possibility of termination of your site.
- *Mowing:* Mowing of campsites will vary from day to day, pending weather and scheduling. We will try our best to notify you when your site will be mowed. When your campsite is being mowed, we ask all campers to be courteous to campground staff and remove all objects/vehicle from campsite area.
- *Fireworks:* No forms of fireworks, including sparklers.
- *Birds/Wildlife:* Do not feed the birds: seagulls, geese, ducks, or any other wildlife. This includes bird feeders attached to or around RV's, camping unit/trailer.
- *Equipment:* No rollerblades, mopeds, skateboards, or bicycles are permitted on decks, gazebo/pavilion, playground equipment, sidewalks, or inside buildings for safety reasons. No golf carts, ATV's, UTV's and or any motorized "kiddie" vehicles allowed in the campground. Small "kiddie" swimming pools, hitting golf balls, or practicing golfing are not allowed in the campground.
- *Garbage:* Please place all garbage in designated dumpsters located inside the campground. Please do not dispose of any building materials, mattress, grills, awning, etc., in dumpster.
- *Solicitation & Sales:* You are not permitted to sell, solicit, peddle, rent any goods/wares, collect any money, or hang for sale signs within the campground.
- *Y Splitters:* Y Splitters may be placed on water spigots with a vacuum breaker located on both downstream hose connections. Any sprayers may be temporarily installed while watering flowers, etc., but MUST be removed after use.
- *Washing vehicle/camper unit:* \$20 per wash, must pay and have office approval.
